### **Summer Schedule**

- **June 10, 2019 – August 18, 2019, any 4 days out of 7, from about 9:30am – 4:15pm Monday through Friday and until 5:15pm on Saturdays and Sundays**

### **Fall Schedule**

- **August 21, 2019 – October 25, 2019, from about 9:30am – 4:15pm, Wednesday through Sunday**

Ride Operators are responsible for operating our simple, friendly rides and keeping Children's Fairyland an inviting, safe and happy place to visit. Park Attendants are the main point of contact between Fairyland and our guests, and critical to our success. Park Attendants must be very flexible, reliable, responsible, adaptable and able to handle a variety of duties while being courteous, friendly, and helpful to all guests.

This position is responsible for the safe operation and daily cleanliness of our rides and attractions; enforcing all park rules and regulations including managing height requirements of riders; checking safety restraints; making ride announcements; following documented ride operation procedures; implementing emergency procedures for rides when issues arise; executing park emergency and lost child procedures.

- Happy, Outgoing, Flexible, Energetic
- Has experience with young children in day care, camp, recreation, or school programs
- Dependable, Reliable, Open Availability
- Passionate about providing Excellent Customer Service to adults and children
- Think on your feet and problem solve to ensure all guests
- Be able to act calmly and logically in the event of an emergency
- Follow instructions, be proactive, know how to work well with a team and management
- Maintain clean, well groomed, and tidy appearance and uniform
- Make customer service and safety a priority

Requirements

- You must be at least 18 years age to apply.
